**CONSIDER THE APPROVAL OF THE MINUTES FROM THE JANUARY 26,
2015 MEETING**

Chairman Johnston asked if there were any comments, questions or concerns regarding the minutes as presented. As there were no questions, concerns or changes, Chief Fahd made a motion to approve the minutes. Ken Radliff seconded the motion. A roll call vote was taken. All were in favor. The motion passed.

**CONSIDER THE APPROVAL OF THE MINUTES FROM THE APRIL 20, 2015
MEETING**

Chairman Johnston asked if there were any comments, questions or concerns regarding the minutes as presented. As there were no questions, concerns or changes, Chief Fahd made a motion to approve the minutes. Ken Radliff seconded the motion. A roll call vote was taken. All were in favor. The motion passed.

**CONSIDER THE CLOSURE OF PINE STREET AT VAN RENSSELAER
AVENUE AS PART OF THE QUIET ZONE INITIATIVE**

Chairman Johnston stated that this request is part of the Quiet Zone initiative and is in accordance with Federal Railway Administration guidelines. This is one more step in the process agreed upon between the City and the Department of Transportation which should be completed by December 1, 2015. His recommendation was to approve the request. CONSIDER THE CLOSURE OF PINE STREET AT VAN RENSSELAER AVENUE AS PART OF THE QUIET ZONE INITIATIVE

CONSIDER THE INSTALLATION OF TWO "TURN" SIGNS WITH ADVISORY SPEED PLAQUES FOR WHITEHALL STREET.

This request was submitted by Chairman Johnston. Chief Fahd made a motion to install the signs. Ken Radliff seconded the motion. A roll call vote was taken. All were in favor, the motion passed.

CONSIDER THE REMOVAL OF A RESIDENTIAL HANDICAP SIGN AT 296 REMSEN STREET

This request was submitted by Chairman Johnston. Chairman Johnston stated that the resident who requested the sign passed away. Chief Fahd made a motion to remove the sign. Ken Radliff seconded the motion. A roll call vote was taken. All were in favor, the motion passed.
